REAUTHORIZATION OF KEY PROVISIONS OF THE VOTING RIGHTS ACT OF 1965

FYI--below is a summary of the VRA and how it affects all minorities and persons that speak other languages. This information is from the Rainbow/Push Coalition.

Background and Summary

Question #1: Which provisions of the Voting Rights Act will expire in August 2007 unless Congress acts to reauthorize them?

<u>Answer</u>: There are three key parts of the VRA that will expire in 2007 unless reauthorized:

? Section 5 of the Act which requires certain jurisdictions to obtain approval (or "approval requires proof that the proposed change does "not have the purpose and will not have the effect of denying or abridging the right to vote on account of race or color [or membership in a language minority group]." ? Section 203 of the Act which requires certain jurisdictions to provide bilingual language assistance to voters in communities where there is a concentration of citizens who are limited English proficient. This provision was added to the VRA in 1975.

? The portions of Sections 6-9 of the Act which

authorize the federal government to send federal election examiners and observers to certain jurisdictions covered by Section 5 where there is evidence of attempts to intimidate minority voters at the polls.

Question #2:

Where does Section 5 apply?

Answer: Section 5 applies to any state or county where a literacy test was used as of November 1, 1964, and where less than 50% of the voting age residents of the jurisdiction were registered to vote, or actually voted, in the presidential election of 1964, 1968, or 1972. Currently, Section 5 affects all or part of 16 states: All Alabama, Alaska, Arizona, Georgia, Mississippi, Louisiana, South Carolina, and Texas. Most of Virginia, 4 counties in California, 5 counties in Florida, 2 townships in Michigan, 10 towns in New Hampshire, 3 counties in New York, 40 counties in North Carolina, and two



counties in South Dakota.

Question #3: What kinds of laws and practices affecting voting must be precleared?

Answer: Because any change in election law or procedure could potentially discriminate against minority voters, proposed voting changes in covered jurisdictions must be submitted for preclearance. Examples are plans for redistricting, annexation, at-large elections, re-registration requirements, polling place changes, and new rules for candidate qualifying. The Supreme Court has recognized that seemingly insignificant changes can really be subtle attempts discriminate.

Question #4: How can a jurisdiction be removed from Section 5 coverage?

The Act Answer: includes a "bail-out" mechanism, which allows iurisdictions to removed from Section 5 coverage if it can show that (1) it has been in full compliance with the preclearance requirements for the past 10 years; (2) no test or device has been used to discriminate on the basis of race, color, or language minority status;

and (3) no lawsuits agains against the jurisdiction, a 11 e g i n g v o t i n g discrimination, are pending.

Question #5: Where do the minority language provisions of the Act apply?

The language Answer: assistance provisions of the VRA apply to four groups: language Americans Indians, Asian Alaskan Americans, Natives, and those of Spanish heritage. Α community with one of these language groups will qualify for bilingual assistance under Section 203 of the Act if (1) more than 5% of the voting-age citizens in a jurisdiction belong to a single language minority community and have limited English proficiency; OR (2) more 10,000 voting-age than citizens in a jurisdiction belong to a single language minority community and are LEP; AND (3) the illiteracy rate of citizens in the language minority group is higher than the national illiteracy rate. Jurisdictions qualify for language assistance under Section 4 (f)(4) of the Act if (1) over 5% of the voting-age citizens on November 1, 1972 were members of a single language minority group; (2) the U.S. Attorney General finds that election materials were provided in English only on November

1, 1972; and (3) the Director of the Census determines that fewer than 50% of voting-age citizens were registered to vote on November 1, 1972 or that fewer than 50% voted in the November 1972 Presidential election.

As of 2002, there are 382 local jurisdictions that need to provide language assistance in Spanish and 119 that must provide assistance to Asian Americans, Alaska Natives, and/or Native Americans. Because some of these jurisdictions overlap, a total of 466 local jurisdictions across 31 states are covered by the language minority provisions of the Act.

Question #6: Have these provisions been previously reauthorized?

Answer: Yes. Section 5 was reauthorized with broad bipartisan support in 1970, 1975, and 1982 (for 25 years). Section 203 was enacted in 1975, and

reauthorized in 1982 and 1992 (for 15 years).

Question #7: Should Section 5 of the VRA be made permanent?

Answer: While making this provision permanent may seem attractive, doing so would make it vulnerable to a constitutional challenge. Because Section 5 is race conscious, it must be able to withstand "strict scrutiny" by the courts. What this means, in part, is that the provision must be "narrowly tailored" to address the harms it is designed to cure. Many legal experts question whether the Court would find a permanent Section 5 to be "narrowly tailored," such as to survive a constitutional attack.

Question #8: Should Section 5 apply nationwide?

Answer: No. A "nationwide" Section 5 would also be vulnerable to constitutional attack as not "narrowly tailored" or "congruent and proportional" to address the harms it is designed to cure, as required by the Supreme Court's recent precedents. Section 5 is directed at jurisdictions with a history of discriminating against minority voters. In addition, nationwide application of Section 5 would be extremely difficult to administer, given the volume of voting changes that would have to be reviewed. This expansion of coverage

would dilute the Department of Justice's ability to appropriately focus their work on those jurisdictions where there is a history of voting discrimination.

Question #9: Why are congressional hearings important for the reauthorization effort?

Answer: The Supreme Court has made clear in recent years that it will require Congress to establish a detailed record, through hearings and legislative findings, in order to ensure that provisions such as these survive constitutional scrutiny.



Dear Top Ladies of Distinction Member:

We are writing to you together because we share a concern, and we share the hope that you will help us do something about it. We are both concerned about the education our young African American men and women need—but all too often, do not get.

Top Ladies of Distinction has nurtured the talents of countless young people through its Top Teens of America Program. And the United Negro College Fund has helped educate more than 300,000 students through its network of historically black colleges and universities.

But we are writing to you today about the young African Americans who are not getting the college education they need—because they cannot afford it. More African Americans than ever are getting their high school diplomas and enrolling in college. But mostly because of financial concerns, African Americans are graduating from college at just half the rate of students from the majority population. As a result, after all the progress we've made, the educational attainment gap between African Americans and the majority population is not narrowing, but getting wider. And because college education today is what a high school diploma used to be—the minimum requirement a young person needs to get a good job—economic prospects for many young African American are moving in the wrong direction.

What can we do about? Historically black colleges and universities (HBCUs) are an important part of the answer. African Americans who go to HBCUs, especially the small, private schools that belong to UNCF, have a higher graduation rate than those who go to other colleges. HBCUs also have tuitions that are much lower than those at other private colleges, making them more affordable to students from low-income families.

Your gift to UNCF will give these schools the help they and their students need. It will help them offer the new courses and new technology that the 21st century job market demands. It will help them offer the student services that assist students in making the transition from living at home during high school to going away to college. And it will help them keep tuition low.

Help from UNCF and from generous donors like you made a difference for Kendra Tolden. For Kendra Tolden's family, making ends meet in Austin, TX was a constant struggle. Her father had to hold down multiple jobs to put food on the table, and her mother had to take on the responsibility of caring for her 100-year old grandmother. Faced with a lack of role models in her community, Kendra was at risk of having to drop out of high school like her older brothers and sisters. But with drive and vision that matched her intelligence, she broke the cycle of underachievement and graduated from high school. And thanks to concerned professionals like you, Kendra was able to attend UNCF member school Huston-Tillotson University and study accounting.

The resolutions as presented to the board as of October 8, 2005 by Lady Dorothy Buckhanan are set forth below:

Resolution #1 - Health: Status of Women

Whereas October is celebrated nationally as the month for breast cancer awareness and

Whereas this insidious disease disproportionately affects women of color in this nation and

Whereas Breast Cancer and Health is a major component of our Status of Women Monthly Health Watch initiative and

Whereas early diagnosis and treatment has been shown to significantly increase the survival rate of women after a breast cancer diagnosis and

Whereas the current Mastectomy bill before congress will extend hospital stays of women who've been admitted for surgery, to a more reasonable timeframe, in order that critical post surgical care can be provided and also so that recovery can move smoothly

Therefore be it resolved that Top Ladies be encouraged to write letters within the next 30 days to their U. S. Congressional Delegation, urging support and passage of this critically vital legislation.

Resolution #2 - Economics-Community Partnerships

Whereas Hurricane Katrina and Rita has forever changed the landscape of the Gulfport region of this country and

Whereas many of our fellow Top Ladies, Top Teens, Lords, families and friends have been impacted in a major way by these disasters and

Whereas efforts are now underway to re-build many of these areas, particularly New Orleans, which will result in one of the largest construction projects ever in this country, estimated at billions of dollars and

Whereas many of these projects will generate family sustaining wages which could greatly assist many displaced residents in getting back on their feet economically after these devastating losses of homes and jobs and

Whereas most of the contracts awarded to date have been non competitive in nature, with many of these jobs going to non-African American workers, who are not natives of the affected areas.

Therefore be it resolved that TLOD join with other national organizations in urging that all future contracts to repair or rebuild these devastated areas be awarded through a competitive bid process. Further, local chapters are asked to join in this effort by again writing letters to members of congress, insisting on involvement on Federal contracts by those residents who wish to return to their home towns to assist with re-building. This is an unprecedented employment and economic development opportunity.

Resolution #3 - Courtesy

Whereas Lady Peggy Lewis LeCompte -10th National President, has convened, along with her national board, this Fall 2005 Parliamen-Top Meeting-the first of her second term of office and

Whereas the "Mobilizing" theme and message will continue to be our guiding light for the next two years as the team moves TLOD and TTA to even greater heights and

Whereas Lady Peggy LeCompte has continued to challenge the membership towards enhanced service in the areas of 5 star programming and membership and

Whereas Lady Peggy's tenure as national president has been marked by energetic leadership, innovative ideas and historic chapter participation in programs.

Re: William Bennett's Racist Statement and the Response of Top Ladies of Distinction, Inc.

WHEREAS, 36.2 million people or 12.9% of the total United States population are of African American ancestry;

WHEREAS, Americans of African ancestry have historically contributed to the development, productivity and well-being of the United States of America since its inception;

WHEREAS, the total population of the United States is racially, ethnically and culturally diverse and our differences make this country great;

WHEREAS, persons of each racial and ethnic population in the United States should be valued, respected and accorded dignity:

WHEREAS, William Bennett, former Secretary of Education for the United States, made erroneous and racially disrespectful, demeaning and insensitive comments on his radio program, *Morning in America* on September 28, 2005;

WHEREAS, William Bennett's response and comments to a question about a woman's right to choose was,

"But I do know that it's true that if you wanted to reduce crime, you could. If that were your sole purpose, you could abort every black baby in this country, and your crime rate would go down. That's an impossible, ridiculous and morally reprehensible trung to do, but your crime rate would go down. So these far-out, these far-reaching, extensive extrapolations are, I think, tricky."

WHEREAS, Top Ladies of Distinction deplores the abuse and misuse of the American radio airwaves, by the insensitive, raeist comments of former Secretary of Education William Bennett;

RESOLVED, that the Top Ladies of Distinction respectfully petition the Federal Communications Commission (FCC) to take immediate action to officially sanction and reprimand former Secretary of Education William Bennett for his comments;

RESOLVED, that the Top Ladies of Distinction, Inc., membership will contact its local, state and national elected officials to inform them of its outrage and opposition to former Secretary of Education William Bennett's comments and request their support of the call for FCC sanction and action.
